



## STANDARD TERMS AND CONDITIONS OF SALE

**FREIGHT:** F.O.B. Our Warehouse

**TERMS:** C.O.D. or open account upon approval of credit

**PRICES:** Subject to change without notice. All shipments will be at prices prevailing on the date of order.

**RETURNS:** No product or part can be returned for credit unless written authorization by Redneck, Inc. has been given in advance. Returned merchandise that was shipped as ordered is subject to a minimum 15% restocking charge, and possibly more, depending on the condition and age of the returned goods. The return of obsolete, discontinued, modified or special parts is not permissible. Merchandise shipped in error will be allowed full credit upon return.

**PAST DUE ACCOUNTS:** Accounts past due are subject to credit hold or C.O.D. Once the account is brought current, Redneck, Inc. reserves the right to determine if open account privileges should continue, or be withdrawn. Interest of 1½% per month (18% annual rate), or such other rate allowed by state law, can be charged on past due accounts.

**SALES TAX EXEMPTION:** All merchandise sold by Redneck, Inc. is intended for resale. To avoid being charged sales tax, please provide us with your Tax Exemption Certificate.

**DAMAGES OR SHORTAGES IN SHIPMENT IN ROUTE:** Redneck, Inc. is not liable for damage or loss of merchandise once it has left our warehouse. Purchaser is solely responsible for filing claims against the carrier for any loss or damage, upon receipt of the merchandise. We will make a reasonable attempt to assist you in securing an adjustment for any loss or damage, provided you have filed with the carrier. Claims for shortages in shipments must be made within 10 days of receipt of goods.

SELLER HEREBY ASSIGNS TO THE CUSTOMER ALL RIGHTS WHICH SELLER, AS PURCHASER, HAS AGAINST SUCH SUPPLIERS FOR BREACH OF WARRANTY OR OTHER REPRESENTATION RESPECTING THE MERCHANDISE. SELLER WILL NOT BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES SUFFERED BY THE CUSTOMER FOR ANY REASON WHATSOEVER.
